Please be aware that this is a contract that requires a deposit to reserve of your appointments. A Non-refundable deposit of 50% of the wedding day fee of \$\_\_\_\_\_ will be required to be paid to hold your date. The balance of \$\_\_\_\_\_ will be due **14 days** prior to the wedding day. The full fee will be charged for all appointments not kept or changed without **30 days** notice of cancellation. Gratuity has not been included and is at your discretion. If you are happy with your services, an 18-20% gratuity is recommended. The bride assumes responsibility of payment to the stylist for *all* members of the bridal party included for styling or make up services.

A trial run for hair and make up is needed for the bride. A minimum of \$450 is required to book our services, not including the trial fee.

## Important Information

- All Brides are required to schedule a trial run for hair and make up no later than 2-3 weeks before the wedding day. Please ensure that you bring all accessories that you intend to wear in your hair. EX: Tiara clips, etc.
- All Bridal party members should come to their appointment with an idea of the look that they would like to achieve.
- All bridal party members should shampoo their hair the night before their scheduled service. Updos/ styles will retain their look longer when hair is not freshly shampooed or too dirty. Please come to appointment with blowdried or air dried hair. PLEASE DO NOT FLAT IRON HAIR PRIOR TO APT.
- All Bridal party members are advised to wear buttoned down shirts or robes.
- Please notify me if anyone has allergies to hair/ make up products that we should be aware of.
- It is essential that all members of the bridal party arrive at least 5 min prior to their scheduled time of services. Any member arriving more than 10 min late, may not be able to receive their scheduled services.
- Please notify me of any changes to the wedding day schedule as soon as possible.
